Changes required from [Enrolled SB 299](#) (Governing Practice of Telehealth and a Telehealth Practitioner) Relating to prohibiting certain medical practices; requiring proposed legislative rule regarding telehealth practice by a telehealth practitioner to include a prohibition on prescribing or dispensing gender altering medication to a person who is under 18 years of age

- Includes a prohibition of prescribing or dispensing an abortifacient

#### BOARD OF PHARMACY RULE ADDRESSES

- Permitting Faxed transfer prescriptions
- Updating Rules of Professional Conduct to defined Unprofessional conduct as is standard across the profession
- Removing additional specific education requirement for consultant pharmacists
- List duties of pharmacist (they were originally part of the rules of professional conduct)

#### BOARD OF PHARMACY RULE ADDRESSES

- Including addition of submitting continuing education hours or current national certification proof
- Elimination of 20-hour pharmacy technician training program (duplicative with the requirement for national certification)
- Process for registration under 30-1-27
- Extend time for obtaining national certification to eliminate need for multiple extensions
