


Number of Eligible Prescription Transactions Reported to the PMP

Reporting through 06/30/2025




PMP Reporting - Opioids





Louisiana Prescriber & Pharmacist Searches through AWAxE® and Gateway®

As of July 1, 2025, the Louisiana PMP is interoperable with 789 licensees (EHRs and pharmacy management systems) across the state. The 789 licensees are responsible for 3,908,565 PMP requests in the month of June (see attached). There are an additional 343 licensee applicants pending.
